Flat Rate Water Users payments will be due in accordance with Section 3 of the District's Rules and Regulations.

PAYMENT FOR CROP WATER:

Payment is due upon receipt of the monthly invoice. Payments must be received in the office by 4:00 p.m. the last business day of the month and will become delinquent on the following day. Payments dates are March 29, April 30, May 31, June 28, July 31, August 30, September 30, October 31, and November 29, 2019. Water service will be terminated if payment is not received by 4:00 p.m. on the due date. A 2% penalty will be charged on the unpaid balance without exception. Postmarks are not acceptable as evidence of timely payment. Returned checks will result in a \$30 returned check fee. Thereafter, only cash, cashier's check, certified check or money order will be accepted.
